E. Resolution No. 11-125 – Library Concrete Rehabilitation Bid Award

Mr. Jerrod Wilson of Z & S Steel, along with Aaron Wood of K. L. Wood, Co. will be in attendance to give Council a presentation on the proposed heating system for the Library steps as requested.
