Land Sale to Western Heritage Credit Union

Ordinance No. 2726 is before Council for third reading. This ordinance will authorize the sale of Lots 1 through 11, Block 28, Original Town, City of Alliance, Box Butte County, Nebraska to Western Heritage Credit Union in the amount of \$75,000.00. Copies of the Agreement for Sale of Real Estate and a location map have been made a part of the packet for Council's review.

I. Resolution No. 13-72 – Airport Engineer Contract Amendment

Resolution No. 13-72 will revise the Consultant Agreement with M.C. Schaff & Associates for the preliminary pavement evaluation of Runway 12/30 which defined the scope of the project for all parties involved, including the NDA and FAA. The proposed revision will add Design, Bidding, and Construction Services for Runway 12/30 Bituminous Pavement Rehabilitation.

J. Resolution No. 13-73 – Nebraska State Fly-in Event and Airport Contingency Fund Authorization

This resolution will approve three items with regard to the Nebraska State Fly-in at Alliance. The resolution will authorize the City Manager to enter into contracts following legal review with the exhibitor's participating; accept the cash donation from the 125th Committee; and authorize up to \$3,500.00 from the Airport Contingency Fund.

K. Discussion on Allowing Cell Towers in All Zoning Districts

The City is in receipt of a request of Viaero Wireless to discuss the zoning regulations to allow wireless telecommunications facilities (WCF) in all zoning districts. The Alliance Planning Commission, at their regular meeting May 28, 2013 recommended approval of the request. The City Council did not introduce the proposed ordinance at their June 13th meeting.

L. Establish a Date for a Special Meeting for the Approval of Bills at the End of the Fiscal Year

Staff is recommending a Special Meeting be established for Monday morning, September 30, 2013 to approve final bills for the fiscal year end.
