Honorable Mayor and Council Members:

A bid opening was held on August 4, 2023 for the above referenced project, at the Alliance City Hall Building, Alliance, Nebraska.

The project was advertised for four (4) weeks prior to the bid opening, which meets the City's requirements for notification. Three (3) general contractors received plans and specifications prior to the bid opening.

Two (2) contractors submitted a bid on the project:

Bidder	Base Bid Items 1 -16
Werner Construction, Hastings NE	\$385,985.00
Simon Contractors, North Platte NE	\$649,000.00
Engineer's Estimate	\$375,200.00

The base bid includes mobilization, traffic control, cold milling, pavement fabric installation, 2-inch bituminous overlay and miscellaneous concrete repairs at the following locations:

18 th Street	Box Butte Avenue to 18 th Terrace
21 st Street	Box Butte Avenue to Emerson Avenue

A copy of the detailed bid tabulation is attached to this letter for your review.

The Engineer completed a tabulation of the bid proposals and no mathematical errors were noted.

Each bidder provided a bid bond in the amount of 5% of the bid in accordance with bid proposal requirements.

The bidders provided the following project start dates with their proposal:

Bidder	Start Date
Werner Construction, Hastings NE	August 14, 2023
Simon Contractors, North Platte NE	July 20, 2024

Werner Construction's bid proposal is contingent upon a contract being executed by the August 14, 2023 start date in their bid proposal. If a contract cannot be executed by August 14, 2023 there is an additional \$25,000 in mobilization costs added to the bid proposal.

There was one (1) addendum issued prior to the bid opening. Both bidders acknowledged receipt of Addendum #1 (Dated 7/24/2023) in their bid proposal.

Having reviewed the bid proposals submitted, we make the following recommendation:

We recommend the city accept the bid proposal from Werner Construction in the amount of **\$385,985.00**. We recommend the city execute the contract by August 14, 2023 in order to save the additional \$25,000.00 in mobilization costs.

RESOLUTION NO. 23-60

WHEREAS, The City has determined that streets in the City of Alliance should be improved by bituminous overlay and miscellaneous concrete repairs; and

WHEREAS, M.C. Schaff and Associates, an engineering firm for the City, has let bids for the 2023 Alliance Pavement Rehabilitation Project - Schedule 2 with two bids being received; and

WHEREAS, M.C. Schaff and Associates recommends that the City award the bid to Werner Construction., Hastings, Nebraska, in the amount of Three Hundred Eighty-Five Thousand Nine Hundred and Eighty-Five and 00/100ths Dollars, (\$385,985.00) as the lowest, responsive, and responsible bidder for Schedule 2 Street Rehabilitation Project.

NOW, THEREFORE, BE IT RESOLVED, By the Mayor and City Council of Alliance, Nebraska, that the Mayor is authorized to sign a contract with Werner Construction, Hastings, Nebraska, for the Schedule 2 - Alliance Pavement Rehabilitation Project, as the lowest, responsive and responsible bidder obtained by M.C. Schaff and Associates.

BE IT FURTHER RESOLVED, that the contract for asphalt overlay as specifically set forth in the bidding documents, is hereby awarded to Werner Construction in the total amount of Three Hundred Eighty-Five Thousand Nine Hundred and Eighty-Five and 00/100ths Dollars, (\$385,985.00) and will be paid from Account No. 24-41-41-51-930.

BE IT FURTHER RESOLVED, Staff shall contact the successful bidder so that contractual arrangements can be finalized, and work can commence according to the terms of the bid.
